#### **General Membership Meeting Minutes**

#### **Standing Items:**

1. Meeting called to order by Shannon Voerster at 4:35 p.m.

- 2. Five Minutes of Fun "Most Embarrassing Parent Moment" by Laura Loshek
- 3. Approval of the September Meeting Minutes by Sharon Deziel
  - A. Motion to approve minutes by Misty Nickle, seconded by Shannon Voerster motion passed
- 4. Referendum Presentation by Mike Johnson, Assistant Superintendent
  - A. Presented short video introducing upcoming voting referendums on November 7; explained how the district is financed; voters need to make their own educated decisions on these questions
  - B. Discussion over the three referendum questions:
    - i. Q1 Operating Levy Renewal of \$780.72 does not involve tax increase; if this does not pass there may be an increase in class sizes
    - ii. Q2 Additional \$375/Pupil for 10 Years to restore general fund balance to meet school board policy; ability to pass means a much better rate for bonds (for construction projects); would help maintain class sizes at elementary level, cover special education and pre-K costs; if this does not pass reductions will be made over the next two years
    - iii. Q3 Ten-year \$2M Annual Capital Projects Levy; focuses on technology in advancing educational software and modernizing aging devices; supports programs such as Infinite Campus, and licensing software such as SeeSaw; would provide wireless access points and connectivity; 30% toward technology staffing support
- 5. Principal's Report by Laura Loshek
  - A. Conferences coming up: grades K-2 have implemented a Standards-Based Progress Report Grading using state standards in benchmarks. Slide presented demonstrates a 1-4 grading scale that does not correlate to a traditional letter grade system. 1= starting progress, 2=even more progress, 3=benchmark, 4=exceeding grade level. Common at beginning of year to see 1-2's, goal to achieve 3 by year-end. Gifted/Talented Program also uses MAP testing for math/reading and other assessments to identify candidates. Teachers are still learning the new system. Feedback positive on focusing on a student's progress towards goals.
- 6. Volunteer Coordinator's Report by Karri Norris & Marissa Genereux
  - A. Hoping to divide shifts so parents can participate with student(s) at least part of the evening; volunteer positions posted on Sign-Up Genius
- 7. Treasurer's Report/Budget Approval by Misty Nickle
  - A. Discussion contingency fund requests are typically over \$500
  - B. Motion to approve budget by Karri Norris, seconded by Bobbie Grummons, motion passed



## Operating Levy Renewal of \$780.72/Pupil

Renewal of the levy would allow South Washington County Schools to maintain the current level of high quality educational services, ensure operating funds are in place to continue maintenance and programming for all schools, and maintain effective class sizes for a positive learning environment.

This referendum has been in place for 20 years and would result in no tax increase.

Without the passage of question one, the district would have \$15 million in budget adjustments.



### Additional \$375/Pupil for 10 Years

Approval of question two would increase the general fund of the district by \$7.5 million, supporting the financial health of the district.

The priorities for the additional funding include restoring the general fund balance to align with school board policy, maintaining educational programs and opportunities, and training and supporting high quality staff.

If question two fails, South Washington County Schools would face as much as \$8 million in budget reductions over the next two years. Potential cuts could impact class sizes, program offerings, athletics and activities.



# Ten-year \$2M Annual Capital Projects Levy

Approval of question three would support learning needs through technological advancements in educational software and modernize aging devices.

It would approve a \$2 million levy annually for the next 10 years.

Without the additional funding through the levy, the general fund would have to offset costs. These items are the cost of providing technology to meet the needs of today's and tomorrow's learners through modern and reliable technology.
